- The Juralco Gable Sun Shade must only be installed in accordance with its Manual © Louvrelite.
- Any deviation from that specified in the Juralco Gable Sun Shade manual must only be in accordance with the site © Louvrelite specific PS1 with site-specific calculations and drawings listing the non-standard details.
- The Juralco Gable Sun Shade must only be fabricated/installed by a Juralco approved fabricator © Louvrelite.
- Upon completion of the installation the fabricator must supply the owner with a PS3 (Construction).
