• The Juralco Louvrelite Window Surround System must only be installed in accordance with the ® Juralco Louvrelite® Window Surround System manual

• Any deviation from that specified in the Juralco Louvrelite Window Surround System manual must only be in accordance with the site-specific PS1 with site-specific calculations and drawings listing the non-standard details

• The Juralco Louvrelite Window Surround System must only be fabricated/installed by a Juralco approved fabricator
